



Administrative Remarks, CG-3307, for SELRES ADT-AT Waivers

In accordance with the recently promulgated Reserve Duty Status and Participation (RDSP) Manual, COMDTINST M1001.2 (series), commanding officers or officers-in-charge are authorized to waive reservists' Annual Training (AT) requirements for sufficient cause. Requests for waiver of the Active Duty for Training (ADT)-AT requirement must be submitted via memorandum from the member to their commanding officer or officer-in-charge.

Approved ADT-AT waivers must be documented via Administrative

Remarks, Form CG-3307. A template is available for download and can be found by following the instructions in the references section below.

In addition to the standard distribution of CG-3307 entries, a copy of the request and approval must be provided to District RFRS, DOL-1, or PAC-13. Also, a waiver only excuses completion of the AT for participation standards. It does not waive, replace, or count for points required for a qualifying year of service for retirement.

Additional details regarding ADT-AT waivers can be found in Chapter 3.B.r. (3) of the RDSP.

It does not waive, replace, or count for points required for a qualifying year of service for non-regular retirement. You must still meet the 50-point minimum for a qualifying year of service for retirement during your anniversary year ending on DDMMMYYYY.

(Enlisted only) You must still meet the requirements in order to be eligible for the Coast Guard Reserve Good Conduct Medal (RGCM), in accordance with the Coast Guard Military Medals and Awards Manual, COMDTINST M1650.25 (series).

ADT-AT waivers may not be granted for two consecutive years without approval of District (dxr), DOL-1, or PAC-13. Date of last approved ADT-AT waiver: N/A or DDMMMYYYY.
