FY21 Scheduling Deadlines for ADT, IDT, RMP & ATPs

This Reserve Information Bulletin is a reminder of the FY21 Important Scheduling Dates and Direct Access deadlines for all reservists and commands.

01 May 2021: Deadline for SELRES members to request ADT-AT/OTD orders in Direct Access. Since SELRES members may reschedule ADT/OTD orders entered after the 01 May 2021 deadline without a waiver, the 01 May 2021 deadline remains unchanged. For more information regarding ADT/OTD scheduling requirements, members and commands should refer to ALCOAST 345/20: FY21 RESERVE ACTIVE DUTY FOR TRAINING (ADT) SCHEDULING REQUIREMENTS.

30 June 2021: Deadline for SELRES members to enter all command approved, paid IDT, RMP, ATP drills. It is strongly encouraged that the paid IDT, RMP, ATP drills be entered by the member and left in a pending status in the event of date changes. Drills left in a pending status can be changed after the deadline without a waiver. However, drills in an approved status, or a request for new entry will require a waiver approved through the command and by CG-R82 prior to the convening date of the drill. For more information regarding the deadline change to from 01 May 2021 to 30 June 2021, members and commands should refer to ALCOAST 057/21: FY21 RESERVE INACTIVE DUTY TRAINING (IDT), READINESS MANAGEMENT PERIOD (RMP) SCHEDULING REQUIREMENTS AND WAIVER PROCESS-UPDATE.

01 July 2021: DA controls will be locked for all entry of IDT/RMP/ATP paid drills.

15 August 2021: Last day IDT, RMP, ATP drill (for pay) waivers accepted by CG-R82 for approval consideration.
