Off-Season Extended Active Duty Opportunity for Human Resource Specialists (O4 & O3)

The CG Office of Personnel Management (PSC-opm) is seeking Reserve or Active Component Officers to support critical fill positions at within the Human Resource field. The Personnel Service Center Military Programs office is looking for an O-4 to serve as the Section Chief in PSC-PSD-Field Support (POSN 00029097). The member selected for this position will be responsible member benefits programs to include GI Bill, DEERS/RAPIDS, TSGLI, BAH protection, Family Stability Act, Coast Guard Voting Assistance Program, casualty matters, and military funeral honors.

Base NCR is looking for an O-4 to serve as the Personnel Support Department Head (POSN 0001756). The member selected for this position will lead and manage a department of 85 members (1 Officer, 35 enlisted, 9 GS, 35 Non-Appropriated Funds employees and 5 reserves). The Base NCR Personnel Support Department provides regional support for personnel & admin and pay and human resources to over 4,300 + customers. They also manage the HQ Fitness Center and the largest CG Child Development Center. Finally, the Personnel Support Department Head oversees regional MWR activities to include the CG Ball & CG DAY Picnic.

Commandant (CG-1R) is looking for an O-4 to serve as RW30 Implementation and Sustainment Team Leader (POSN 00071216). The member selected for this position will serve as the lead Change Management Champion for Mission Ready Total Workforce (RW30) Strategic Inlook Implementation efforts and foster collaboration across all RW30 stakeholders and Working Groups. This billet will lead the implementation efforts by facilitating initiative brainstorming, enabling cross functional communication, establishing knowledge management and metrics, enabling CG-wide RW30 comms & scheduling / attending recurring meetings on high-priority initiatives to ensure smooth execution of all initiatives. The Baltimore Yard is looking for an O-3 to serve as the Yard Military Support OPS (POSN 00017493). The member selected for will carry out duties equivalent to Base Personnel Department Head with some additional logistics responsibilities at the CG's largest industrial facility & only full service shipyard. They will supervise 2-GS, 2-CWO, 1-E8, 5-E7, 40-(E2-E6) providing Base support services (security, military police, admin, MWR, galley, barracks) to 2,200 personnel across 14 operational & mission support commands incl SFLC, Sector MD-NCR, APO, & 175-WLM. Manages \$400K AFC-30 and \$300K NAF annually.
